But first, a caveat: It is much harder to get information on women through the sources I have available to me. I may have missed some. Let me know if that is the case. First, Violet (Eberly) Rankin (1925-2003) is buried with her husband, John; her step-father, Arthur Boose, and mother, Martha (Carpenter) Boose; an aunt, Susan M. (Carpenter) Rineer; and an uncle, Robert Carpenter and his wife, Miriam. They are in Section 7 behind the old section. Violet was a member of the Cadet Nursing Corps at Lancaster General Hospital from Apr. 1, 1944 to Oct. 9, 1946.

The obituary of Justine Vivian (Phillips) Geyer (1922-1988) states that she was an apprentice seaman in the WAVES in WW II. I also found her burial record with the Commonwealth of Pa. Dept. of Military Affairs. She was the wife of Henry Geyer. They are buried to the right of the driveway with Henry's parents, Walter and Lizzie Geyer.

Betty A. (Maurer) Fizz (1924-1998) rests with her husband, Stanley E. Fizz, in the flat marker section at the back of the cemetery. Betty is listed in the US Dept. of Veterans Affairs Death File. Her dates of service in the WAVES are given as Sept. 5, 1944 - July 14, 1945.

Loretta G. (Collogan) Mayfield (1925-2004) served in the WAVES in WWII according to her obituary. She is buried with her husband, Dean H. Mayfield, also a WWII veteran in the small East section. It is very hard to find verification of service for Women Accepted for Volunteer Emergency Service, at least through the resources I have available to me. At least 84,000 women served in the program, not only as nurses and secretaries, but also as airplane mechanics, control tower operators and in intelligence. The "Emergency" designation implied that female service would end when the war ended. But the WAVES continued until 1948 when women were admitted to the regular Navy.

Finally, there is Carrie M. (Landis) Wertz. According to her obituary. Carrie was a veteran of the US Navy, Petty Officer 1st Class, and worked as a dispatcher during World War II. I found her Application for Veteran's Compensation filed in 1950, stating that she had served from June 5, 1944 until Mar. 2, 1946. She received \$210.

Carrie was the daughter of Ira and Margaret (Boyer) Landis, and the second wife of Roy Franklin Wertz, who is buried at Greenwood Cemetery, Lancaster.

Here is the WAVES marching song (sung to *I Want To BE A Friend Of Yours*), by Betty McClinchie):

I want to be a Navy Wave, MMM, and a little bit more;
 I want to be an Ensign too, MMM, and a little bit more;
 I want to wear a suit of blue, MMM, and a little bit more;
